Waiver & Release of Liability

I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify PCYS, Eric Wiberg and WWGS, and Stan Anderson and Camp Shutout from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my participation in the goalkeeper training program.
